Two or three years ago, by resolution of the Board, the writer was permitted to transfer a strip of land on our property known as the sand pit adjoining the Canadian National Railways on the north side of the Town to the Canada Crushed Stone Corporation and the strip of land estimated on at that time was a very small one and we based the price of same at \$350.00, with the request that a surveyor should make measurements of the amount of land and on receipt of the surveyor's report we would sell them the land in question. 

Referring to the writer's conversation with your Mr. Henry Bertram in regard to the points raised by your President in New York in connection with the Deed of the small piece of land to the Canada Crushed Stone Corporation.

We beg to say that the lands being described as part of the lands owned by one Bertram undoubtedly means the lands owned by your Company, it is simply the surveyor's way of writing out the description.

There is in the description a distinct reservation to you of the rights to operate and run cars over a spur line, to load and unload cars, to construct and maintain a spur line, switch or siding connecting with the spur line, and if the Grantee fails to construct said spur line, or if it removes the same or allows it to become unfit for traffic you have the right to construct and maintain a spur line. So, you are perfectly protected and adding anything further after the covenants would be superfluous. This is the usual form of Deed used in our Province and the covenant that the


PROFILE of RAGLAN ST
